## OAA-ANU LECTURE - WEDNESDAY 3 OCTOBER 2018

The Order of Australia Association (OAA)-ACT Branch, in partnership with The Australian National University invites you to the 2018 OAA-ANU Lecture presented by Professor Ann McGrath AM at 5.30 pm on Wednesday 3 October at the Common Room, University House, 1 Balmain Crescent, ACTON.

The lecture topic will be:

### TIME IMMEMORIAL? - DATES, HISTORY AND THE DEEP HUMAN PAST.



The concept of time immemorial has poetic resonance, but it also has legal and historical import, dating back to Blackstone's commentaries on the Laws of England in the eighteenth century. This lecture will discuss its uses by the Cherokee in the United States in the 1830s and in more recent Australian cases. Although Australia's Indigenous past has often been referred to as 'timeless', new archaeological research is delivering a series of hard dates, as well as evidence of inventions and dynamism. Can new periodizations of the deep past insert themselves into the

collective imagination like the anniversaries of British 'landings' and 'discovery'? For the purpose of developing a 'deep history' beyond European memory, historians would need to pay attention to Indigenous modes of historical practice and to develop new techniques for understanding Indigenous art, landscape-based memory practices and narratives. More radically, they may need to go beyond dates and to consider other kinds of temporality.



Ann McGrath AM is the Kathleen Fitzpatrick ARC Laureate Fellow and Professor of History at the Australian National University. Her Laureate project is entitled 'Rediscovering the Deep Human Past: Global Networks, Future Opportunities.' She is a Fellow of the Academy of Social Sciences and the Academy of Humanities. Her most recent book, *Illicit Love: Interracial Sex and Marriage in the United States and Australia* won the NSW Premiers History Prize, General Category, 2016. She researches and presents history in a range of mediums, including the prize-winning film *Message from Mungo* (Ronin Films 2014, with Andrew Pike) and in digital works. She co-wrote *How to Write History that People Want to Read* with Ann Curthoys (2009 2011), and with Mary-Anne Jebb, she co-edited *Long History, Deep Past* (2015).

Ann was appointed a Member in the Order of Australia in June 2017 *for significant service to the social sciences as an academic and researcher in the field of indigenous history, and to tertiary education.*

A retired diplomat, Di worked for the Department of Foreign Affairs and Trade (DFAT) from 1973-2004 including as Australian Ambassador to Nepal.

She is Co-Founding Donor and an ongoing collaborator and financial supporter of the **Ifa Lethu Foundation**, a non-profit foundation based in Tshwane, South Africa, established in 2005, and devoted to the development and economic growth of the creative arts sector in South Africa <http://www.ifa lethu.org.za>

Over a number of years, Di has had a long involvement with Canberra community organisations and currently serves in various capacities on the following Committees: Deakin Residents' Association; Friends of the Albert Hall Inc; Pets and Positive Ageing Inc and ACT Rescue and Foster Inc and is a Community member on the ACT Government's Domestic Animal Services Community Liaison Group.

She is a long-standing volunteer for RSPCA ACT and for Domestic Animal Services; more recently for the Northside Community Service Pet Assistance and Wellbeing Service; and a member/volunteer with the Rotary Club of Canberra Burley Griffin. Formerly held positions include Councillor, National Trust ACT; Executive Member, Australian Women's History Forum; community representative, Canberra High School Board; Member, University of Canberra Animal Ethics Committee; and collaborator with Alzheimer's Australia ACT and others on a pilot to deliver dog therapy for dementia residents.

Di is a Life Member of the National Trust ACT, RSPCA ACT, Friends of the Albert Hall Inc, Manning Clark House and Order of Australia Association. She has also established the (private) For Animals Foundation and is Patron of Animal Care for Seniors at Home (Cairns).
