### AUSTRALIA DAY BREAKFAST - 26 JANUARY 2019

Members and guests can enjoy breakfast at the Royal Canberra Golf Club to celebrate Australia Day and acknowledge the achievements of recipients in the 2019 Australia Day Honours List. Our special guest speaker will be Air Chief Marshal Sir Angus Houston AK, AFC (Ret'd). Sir Angus retired from the Royal Australian Air Force in July 2011 after serving for 41 years. He was Chief of the Australian Defence Force from 2005-2011 and prior to that was Chief of Air Force for four years.



He was Chair of the Anzac Centenary Advisory Board from 2011-2013 which provided strategic advice to the Australian Government in relation to the planning and implementation of the Anzac Centenary.

Sir Angus is Chancellor for the University of the Sunshine Coast. He chairs a number of boards and also serves as a board member for numerous organisations. He is a visiting fellow of the Australian National University National Security College and the South Australian Special Envoy for International Trade and Investment. In addition, he is the Ambassador/Patron of a number of charitable organisations. Sir Angus has been awarded honorary doctorate degrees from the University of South Australia, the Australian National University, the University of New South Wales and Griffith University.

Sir Angus was appointed a Knight of the Order of Australia in January 2015 *for extraordinary and pre-eminent achievement and merit in service to Australia, through distinguished service in the Australian Defence Force, continued commitment to serve the nation in leadership roles, particularly the national responses to the MH370 and MH17 disasters, and in a variety of roles in the community.*

In conjunction with the National Council of Young Women Australia’s ‘Sister Act’ program, Ellen and Caitlyn have researched, collaborated, designed and presented a leadership program in ACT Catholic High Schools designed to combat gender balance issues in the workplace and develop the leadership skills of young women. They initiated and led a series of workshops for aspiring and potential female leaders across three Catholic High Schools, engaging guest speakers to help develop skill sets in confidence-raising, communication, interpersonal relations, networking and leadership.

## Ava Starling – Year 6 – Forrest Primary School – Highly Commended Certificate



Ava is an outstanding school citizen who goes above and beyond in caring about, and supporting others in her community. Examples of her long-term initiatives and leadership include persuading her school of the need to use recycled toilet paper, organising a dress-up day to fundraise for the World Wildlife Fund and educating her school’s student body of declining quokka numbers. She has also organised a book drive for the Indigenous Literacy Foundation which resulted in a collection of 18 boxes of books to send to disadvantaged school libraries in remote communities.

## MEMBERSHIP SUBSCRIPTIONS

Some members may have noticed that the Association is now taking a slightly more businesslike approach to reminders about overdue membership subscriptions. A few words of explanation might be helpful.

Over the years, the Association has been quite lenient on overdue subscriptions, maintaining non-financial members “on the books” for some time. In part, this reflected an understanding that subscriptions are easily overlooked but, in some cases, it also reflected a simple reluctance to talk about the subject of money.

Of course, this approach is unfair to those who do pay their subscriptions promptly. It also imposes a cost to the Association in terms of providing services (such as *The Order*) that are unpaid for. And it generates additional work for those volunteers and staff who have to administer our membership and financial records.

Accordingly, the Board recently agreed to introduce a new approach to renewals, as follows:

- The National Office will issue an ‘invoice’ about a month before renewal is due – by email if the Association holds an email address for the member, otherwise by mail.
- If an invoice remains unpaid, the National Office will issue a reminder by mail about a month after renewal was due.
- If the invoice remains unpaid after another month, the National Office will advise the Branch Membership Officer, who may follow up by phone or email.
- If the invoice remains unpaid after six months, the member will be removed from the membership roll.
- Should the required subscription subsequently be paid, the member will be re-enrolled.

There have been one or two small glitches in the transition to this new process, and we apologise unreservedly to any members who have been inconvenienced or felt uncomfortable. But we trust you will understand the importance of keeping our membership and financial affairs in good order.

## NEW ASSOCIATION DISCRIMINATION AND HARASSMENT POLICY

Branch members should be aware that the Association has recently introduced a new Discrimination and Harassment Policy. Some may wonder why a policy like this is necessary in an organisation like ours. There are two reasons. First, it is a requirement of our insurance that we have such a policy in place. But more importantly, in our increasingly complex world, the Association should articulate its expectations of our behaviour towards one another so that we all understand our responsibilities and rights clearly. The broad approach taken by the policy aligns with guidelines set out by the Australian Human Rights Commission.
