## CHAIRMAN'S REPORT

2019 is now well underway. The Branch AGM has been held and the outcomes reported by newsletter to the Branch members. My Chairman's report will be posted on the WA Newsletter page of the OAA website for those who could not attend the AGM.

The Branch reception for the awardees on the Australia Day list was held on 20 March. The Branch is very grateful to the City of Perth and Deputy Commissioner Gaye McMath for hosting the reception, which was a full house. The committee will look at options for larger venues in future.

There were 74 West Australians on the Australia Day list, a significant increase on previous lists. I also noted some younger awardees and am pleased to see nominations being made earlier in life. I certainly look to these younger awardees to be branch committee members in the not too distant future.

While the number of women receiving awards has increased, West Australian women are still under represented as a percentage of our State population. ## AUSTRALIA DAY 2019 RECEPTION

It was a full house when 35 Awardees plus their guests together with over 100 members and guests attended the Australia Day 2019 Reception. The Reception, held at Council House in Perth, was hosted by the Commissioners of the City of Perth Council. A very moving welcome to country was given by Barry McGuire and, representing the Commissioners, was Deputy Commissioner Gaye McMath who welcomed guests on behalf of the Council.

WA Chairman Mark Bonser AO individually recognised each of the new recipients of an award and read a brief citation for each. We were pleased, though saddened, to also welcome family members of 3 recipients of an award who had passed away before the Reception.

## ANOTHER HONOUR FOR A MEMBER OF OUR ASSOCIATION

Admission to the WA Women's Hall of Fame this year was a recognition of the contribution M'Liss Henry OAM has made to the community, especially to those people with special needs. M'Liss, who was awarded an OAM in the Australia Day Honours awards in 2018, has always been involved with horses from growing up on a station in NSW to being the Reserved rider for Australia in the 1964 Tokyo Olympics, and now to caring for 60 horses in a Therapeutic Riding Centre which brings benefits to thousands of people. In an interview with The West Australian Newspaper it was stated that "M'Liss Henry, 75, has joined the dots between horses and people and found a therapeutic connection that continues to change lives".

Shortly after moving to Perth she purchased some ponies and kept them in Claremont where one day she met two couples one of whom had a child with cerebral palsy and the other a child who had had polio. M'Liss offered the children an opportunity to ride and this was the start of what, 46 years later, has become a full time occupation with thousands of people benefitting from riding a horse. The Claremont Therapeutic Riding Centre now has a CEO, a Board and lots of volunteers who keep the Centre running. At least 3 or 4 volunteers are needed each day.

M'Liss estimates that in its 35 year life span, a horse would have had around 20,000 people on its back. It is not only the physical benefits and M'Liss states that one hour on a horse equates to eight hours at the Gym, but the emotional and mental benefits many

people have found. In the early days it was children with special needs who benefitted physically from the experience of riding a horse but now adults have found mental health benefits as well. M'Liss states that "people with Alzheimers, heart problems, breast cancer, everything can benefit". She says that "no matter what a person's condition is, or what their special needs are, you have a goal for them. It doesn't matter how big or small the goal is; it's about giving people a sense of purpose and an aim".

We congratulate M'Liss Henry on her admission to the WA Women's Hall of Fame – a well deserved recognition of sharing her love of horses and bringing joy and benefits to thousands of Western Australians.

## 2019 AUSTRALIA DAY BREAKFAST

Almost 100 members and guests gathered at the Royal Canberra Golf Club with our guest speaker, Sir Angus Houston AK, AFC to celebrate Australia Day and the achievements of ACT and region recipients in the 2019 Australia Day honours list. Sir Angus spoke about two significant anniversaries occurring in 2019: he first described the 1919 Great Air Race, won by two Australian pilots, Ross and Keith Smith, and the subsequent development of a commercial air route between London and Australia, with particular emphasis on the role of Empire Class flying boats in that development, and their role in WW2, before observing that 2019 marks the 20th anniversary of no flying fatalities in the Royal Australian Air Force. While praising the extraordinary achievements of early aviators, he contrasted their approach to risk with the modern culture that has transformed the Air Force's safety record.

## FATHER OF FLUORIDATION IN NSW

The passing on 22 February of ACT Branch member Dr Syd Dobbin AM, former Mayor of Yass, was a reminder that he was instrumental in 1956 in making Yass the first town on the Australian mainland to have a fluoridated water supply. In recognition of his determined efforts to promote fluoridation, he was appointed a member of the Order of Australia in 1986 *In recognition of service to the community, particularly in the field of dental health.* He continued his passionate advocacy for fluoridation throughout his life.

## MORNING TEA WITH JENNY BOWKER AO

Members and guests were treated to a very interesting talk by Branch member Jenny Bowker AO at our first morning tea of 2019 on Thursday 4 April at the Royal Canberra Golf Club. She talked on her personal experiences as a quilt maker and textile artist, and her life travelling the world as the wife of a diplomat, particularly in the Middle East from where she gained inspiration for many of her art works. The audience were privileged to see a number of her stunning creations. Jenny was appointed an Officer of the Order of Australia in the 2018 Queen's Birthday Honours *for distinguished service to Australia-Middle East cultural relations through the preservation of traditional creative and visual arts, and as a textile artist and educator.* Members will have seen Jenny's story in the previous edition of The Order with a striking quilt image gracing the front cover.



## ANNUAL GENERAL MEETING & EVENING WITH SUE PACKER AM

Members and guests gathered at the Royal Canberra Golf Club, Yarralumla on 13 February 2019 to participate in our governance and hear the 2019 Senior Australian of the Year, Dr Sue Packer AM, speak about her Australian of the Year experience.

The AGM saw the 2018 Annual Report accepted and a new Branch Committee elected. Our experiment with providing AGM papers only in electronic format was very successful and this approach will be retained, saving considerably on postage costs and volunteer time.

Sue began her talk by describing the 'surreal' experience of the months and weeks leading up to the announcement of her award, the realities of the presentation night, and the whirlwind of Australia Day in Sydney. She spoke of her delight at being

able to share a day with all 34 Australian of the Year finalists and the wonder of a ride around Sydney Harbour with the other winners aboard the ferry *Victor Chang*. She went on to explain that she has always been passionate about children, even while growing up, and that this had led to her becoming a paediatrician in 1972 and eventually to her work in the child abuse sector. She shared a range of insights from her experience and exhorted all adults to be more interested in children, and to encourage their curiosity. In response to a question, she even gave advice on successful grand parenting! We are very proud to have Sue as a member of the ACT Branch and wish her every success during her tenure as Senior Australian of the Year.




# NATIONAL CONFERENCE 2019





As with any event of this length and complexity there were some unexpected issues to manage. However we were able to handle these so as to minimise impact on the conference.

I also have to thank all those outside of the committee who so willingly contributed to the Conference's success. The various speakers without exception were so pleased to accept the invitation to participate as was everyone else such as the Incat staff, Liferaft Systems Australia and many Branch members and partners.

## AGM 2019 OUTCOMES

Members will be aware that the Agenda for the AGM 2019 contained 7 Items requiring a deliberative vote. I wish to formally advise the ballot outcomes:

- There were 926 valid proxies received assigned to 30 Proxy Holders.
- The proxies included totally directed, totally open and mixed selections.
- There were 119 ballot papers distributed to Members in attendance at the AGM.
- The total number of available votes was therefore 1045.
- In accordance with the Constitution and By-Laws, Special Resolutions require not less than 75% of total available votes,( 784 votes) to be carried.

  - Item 9. Election of Office Holders. **For: 965 Against: 54 – CARRIED.**

## A SUMMARY OF THE SUPPLEMENTARY COMMENTS IN RELATION TO REPORTS

### CHAIRMAN'S AND DIRECTORS' REPORT

The National Chairman offered the following remarks in relation to the Reports before the meeting:

- He was honoured to address the meeting as Chairman of an Order of contributing Australians, and he was confident we would approach deliberations in a spirit of objectivity and cooperation in seeking to engender unity within our Association.
- 2018 was a year of significant activity:
  - Five changes to our Constitution were adopted at the Adelaide AGM. These ensure that members are able to nominate for positions on the National Board.
  - In addition, it was recognised that our Constitution and supporting rules, while complying with regulatory guidelines, needed considerable change. This work has commenced and continues.
  - The Association Strategic Plan was updated to provide a framework for our activities.
  - Key activities included, particularly at Branches and Regional Groups efforts to increase the awareness of the Order and to increase nominations. Considerable success has been achieved both in more nominations overall and in more women being recognised. Once nominated women continue to have a higher success rate than men. Our challenge is to increase the rate of nomination of women and other still under-represented groups.
  - Our finances are well managed. Our Life Reserve has increased, and drawdowns maximised. In addition to Branch Administrative Grants some funds have been provided to Branches for special purposes.
  - Increased email contact with over 80% of our members has allowed reduced costs for the 20% taking The Order electronically and also has provided an ability for Branches to communicate with members quickly, inexpensively and in a timely manner.
  - A dominant theme throughout 2018 has been improving two-way communication between the Board, Branches, Regional Groups and our members. While progress has been good more needs to be done.
- Our National President Mr Philip Flood AO will complete his 3-year term at the conclusion of this AGM on behalf of all members I thank him for his leadership and wise counsel.
- Our incoming National President Ms Heather Ridout will be known to many.
- He thanked both fellow Board members, Branch and Regional Group committees and all members for their ongoing involvement and support for Association activities. only with that participation can we be a truly National Association.

## TREASURER’S REPORT – KEY FINANCIAL RESULTS FOR YEAR ENDED 31<sup>ST</sup> DECEMBER 2018

The underlying surplus for the year was \$86,304 after taking into account state branches and their regions. Following the revaluation of our investments at balance date the net surplus was reduced by \$75,835 to \$10,469. The market had improved by \$84,076 at the time of our annual meeting.

At year end we had 7,863 members who paid membership fees in one of the following ways Annual \$77 (incl GST); Three yearly \$200(incl GST) and Life members \$1,115(incl GST).




## Our Performance 2018

**We welcomed 568** new members, but regrettably lost 444

At year end the Association strength was **7,863** members

**Membership fees** were held at the level of previous years

**Income (Revenue)** increased by 34%, in part as a result of the audit requiring inclusion this year of Regional Groups results

**Assets** were held in both National and Branch accounts. Of the National component, \$1,108,500 was actively invested to generate dividends (and franking credits) that were used to better service member needs. Branches separately held \$425,222, largely in low interest deposits.

**National Investments Value** was down by \$75,835 at end 2018. This investment included the Life Reserve, which must be preserved to service our Life Members for whole-of-life.

**Life Members Reserve** increased by 5.5%

**Branch Administrative Grants (BAG)** and special purpose payments to Branches more than doubled to \$36,041

**Meeting Expenses** increased by 55% as a result of increased activity and the reporting of Regional Groups. National meetings costs increased by 20%

**Surplus** for the year was \$10,469 after adjustment for investments value

**Members Equity** (assets less liabilities) increased by 11.3%

**The Order magazine** costs were reduced by 21%, largely as a consequence of members choosing electronic distribution

**Email** Address provided by **86%** of members

**Year of Birth** provided by **45%** of members

**Electronic copy** of 'The Order' taken by **24%** of members

## A REPORT ON THE MEMBERS' FORUM

- Revision of the membership value proposition, particularly on the Association website.
- Recognition of both Richard and Rysia Rozen for their outstanding efforts over many years in relation to Association merchandise sales.
- Possibility of modified membership fees for those members who might find the current fees unaffordable.
- Inclusion of Board Committee reports in future Annual reports.
- The character of and financial implications of Life Membership.
- The possible amendment of the Nomination System for Directors.
- Recognition of New Recipients in AGM activities and the value of personal invitations to join the Association.

The National Chairman thanked members for their input and noted that time for discussion was limited but undertook to ensure that the issues raised would be considered by the Board.

## THE OLDER WE ARE THE LONGER WE LIVE!

**The older we are the longer we live!** This may seem to be a contradiction, but it is borne out by the Australian Bureau of Statistics (ABS). Each year the ABS produce a series of 'Life Tables' that show the average life expectancy of Australian men and women of varying ages.

The 2017-18 tables show that:

- For a woman aged 60, on average she will live to age 86.78
- For a man of the same age, he will live only to age 83.8

And for those who have passed these 60 'milestones'

- For a woman aged 80, on average she will live to age 90.42
- For a man of the same age, he will live only to age 88.92

At the end of 2018 we had 4,816 Life Members. Each has paid a single membership subscription that they rightfully expect to be there to service their membership for 'whole of life'.

At the end of 2018 the Life Reserve, to which Life Membership payments are credited, totalled \$858,504 (2018 Annual Report – Note 15)

Actuarial calculations are completed annually to determine the funds that may be drawn from the Life Reserve to service Life Members, while maintaining enough to ensure the Reserve last for 'whole of life' of members. This calculation is somewhat complicated as only 40% of Life Members have so far provided their year of birth, necessitating a conservative estimate of the amount that can be drawn down.

While the Life Reserve must be preserved as above, it does not languish in a bank at low or zero interest rate. Instead it is actively invested with the proceeds being directed to support both Life and Annual Member activities throughout our Association.

## CHANGING THE ASSOCIATION CONSTITUTION

Members will recall that some changes were made to the Association Constitution at the 2018 AGM. In bringing these changes forward your National Board recognised that there was a need for much more work if our Constitution was to serve the Association in the years ahead.

The Special Resolution put before the 2019 AGM, requiring a new Constitution by June 2019, did not fully appreciate the progress already made in this matter or the complexity of the task.



After some initial work on the subject, the Board formally set up a 'Constitution Working Group' in October 2018. This Group has been collecting information and the views of Branch Committees since that time. A gap analysis has identified additional points that need to be addressed in a new Constitution for it to be in harmony with the Australian Charities and Not-for-profits Commission (ACNC) requirements.

At a recent National Board meeting a set of guiding principles for a new Constitution were agreed. These included:

- Giving members a greater say in the governance of the organisation
- Branches and Regional Groups given flexibility in their operations to take account of the varying circumstances in States and Regions
- The organisation's 'officers' have clearly assigned responsibilities and are accountable to all members.
- Continuity of efficient and effective management of the organisation
- Documents to be written in plain, understandable language

A Constitution can be prepared only after a 'blueprint' has been prepared for the way ahead, incorporating both principles and operating concepts. To this end Directors and Branch Chairmen are to come together in June to develop this blueprint for the future, to guide the writing of our new Constitution. Branch and Regional Committees will be encouraging members, during May, to put forward their views for consideration during this process.

Your Board has agreed that a new Constitution document will be required, with its foundation the ACNC<sup>2</sup> template. The principles of the new document should incorporate the outcomes of the June Directors' and Chairmen's meeting. It is intended that we develop a foundation Constitution supported by one subordinate suite of policy documents.

## THE DISTRIBUTION OF NOTICES BY USE OF EMAIL

Over 80% of our members have advised an email address. This does offer a much more cost-effective distribution of Administrative Notices compared to the more traditional hard-copy mailout.

The Board has considered this matter in the context of the additional cost consequent upon the notification of Petitions and the recent delayed hard-copy mailout of AGM notices and papers.

Therefore, members are advised that in the future the default method of distributing Administrative Notices, from National and Branch level will be to the notified email address.

It is envisaged that notices relating to AGM's, Newsletters, Invitations and function booking flyers will be primarily distributed by email.

Members not notifying an email address will continue to receive hard copies of notices either through inclusion in The Order magazine or by separate mailout from National or Branches, as appropriate.

Please note; this does **NOT** apply to the distribution of The Order magazine. Members will still retain the choice of electing whether to receive a hard-copy or e-copy of the magazine.

While the Board would encourage the choice of e-copy for The Order, in order to free resources for other uses, it remains a matter of each member's personal choice.

## QUEENSLAND MAILOUT OF FEBRUARY 2019 EDITION

Many Queensland members will be aware of problems associated with the Hard Copy mailout of the February 2019 edition of The Order. Similar problems were not repeated in other States or Territories and indeed were not universal within Queensland or individual suburbs.

The disrupted distribution reflects a failure of AustPost and not of our Printer or their distribution processes.

Our Printer packages and labels the Hard Copies in accordance with AustPost requirements involving 'postcode' consolidation and caging.

Although there is no mandated requirement to include labels reminding AustPost staff to breakdown the consolidated bundles, our Printer has indicated that he will in future include such labels.

## RETURN OF MEDALS – SCAM!!

It has come to the attention of the Association that certain absolute scoundrels are contacting the bereaved relatives of deceased Honours recipients suggesting that their 'medals' need to be returned.

This is totally false and is a malicious scam. Please ignore any such approaches.

## RECORD ATTENDANCE AT THIS YEAR'S WONDERFUL ANNUAL DINNER

Our pronunciation, vocabulary and styles of speech are now confidently and often distinctively ours: whether in the media, education, the arts, parliament, sports and elsewhere. This maturing of our language, and ourselves, can be found in many milestones. We are part of the international community of English, but – stone the crows – at the same time we have found a new identity, and a new way of expressing that identity.*

Many in the audience could relate to the often used Australian expressions that Roly highlighted in his address that are rarely expressed today. Roly spoke with authority and added here and there touches of nostalgic humour that captivated his listening audience.

At the Dinner three outstanding Queensland senior volunteers received their Queensland Branch Senior Volunteer Awards from Michael Rayner AM representing Blight Rayner Architects, the award sponsor. (Refer to separate article elsewhere in this edition of *The Order*).

The Queensland Branch also recognised Professor Paul McNally OAM at the Dinner for his 8 years' service as a Queensland Branch Committee member and Queensland Branch Newsletter Editor.


The Lord Mayor spoke about the qualities of Inspiring Australians which she admires, which was great to hear from different perspectives with her experiences.



She was raised, alongside her brother, by a single mother who worked full-time and frequently experienced relocation of living arrangements and lack of support for education. Hannah was not a regular school attendee, which resulted in attending three different High Schools. Her life changed dramatically when she finally enrolled at The Pavilion School. She enrolled in Distance Learning for her classes but took full advantage of the school environment for support. "Engagement strategies and long-term support from the school enabled me to turn my life around" she asserts. By Year 12 Hannah was already studying two University Law subjects, in which she excelled, receiving the highest marks in the law program. She ran a peer support program, was her school Valedictorian, School Captain and their first student to ever complete Year 12 VCE. This was widely reported in the press and television because of the outstanding achievement of a student from a disengaged background. Hannah then received an early offer to enrol in her current Degree course.

At University, Hannah has maintained a High Distinction grade average, has received excellence awards in numerous Law subjects and was invited to join the Hallmark research program where she





has carried out research about student re-engagement strategies. She carries out extensive community service by advocating for flexible learning schools and is employed as a youth outreach worker for her local council. She is also employed by La Trobe University to work with disadvantaged schools and since year 11 has undertaken research at the Fair Work Commission, firstly in a Projects and Policy Team and later in Award Modernisation. Hannah enjoys being one of La Trobe University's Elite Athletes and has been selected to represent Australia in the World Roller Games this year after being placed second in last year's Australian Women's Open League for freestyle slalom skating.

Hannah is dedicated to re-engaging students who have been excluded or disengaged from mainstream education. Being aware of the powerful influence supportive learning conditions can provide, she strives to assist decision makers in appreciating the extent of the problems. There is no doubt that Hannah is destined to lead in her chosen fields of endeavour.

The generous donor of Hannah's Award is Freemasons Victoria proudly supported by Freemasons Victoria Foundation Limited.

At the conclusion of the Award presentations an Awardee from 2011 James Broinowski, was introduced to Justice Blow AO, to thank him on behalf of the two Awardees present and on behalf of all previous Awardees, for his attendance.

James Broinowski studied viticulture and oenology at the University of Adelaide, Waite Institute. The generous donor of his Scholarship was Mr Baillieu Myer AC.

Tasmanian-born James, graduated in 2013 then sought to attain his ambitions in the field of exquisite fine wines. Thanks to the expertise and generosity of Andrew Margan of Margan Wines, James enjoys a yearly visit to the Hunter Valley in NSW to hone his vintage skills. He has also benefited greatly from his good fortune in working with industry greats Peter Althaus of Domaine A, Coal River Valley, Tasmania and Greg Harrington, Master Sommelier of Gramercy Cellars (USA).

By 2015 James was ready to test the market with his brand Small Island Wines. With capital from crowd-funding, James purchased pinot noir from Glengarry Vineyard in Northern Tasmania. His initial purchase in 2015 was 2.2 tonnes. By 2018 this figure had grown to 20.5 tonnes. His wines consistently achieve outstanding scores of 90 and more. (Three have achieved 96!) In 2016 he achieved a gold medal-winning pinot noir at the Hobart Wine Show.

James has tremendous drive, breadth of vision and leadership. He was listed in James Halliday's top 10 New Wineries of 2018. And his new venture, Drink Co, in Salamanca Place, Hobart, is a highly regarded wine shop and tasting room. Many hours are also spent making and refining wines at the Pooley Winery with Justin and Anna Pooley and Jonny Hughes of Mewstone Wines in the Derwent Valley.

This year James is seeking to establish a Co-Op Winery to support small growers.

James generously donated the proceeds from twelve of his top vintage wines towards a future Scholarship. In his speech he particularly noted that '...this Award changed my life in that it gave me confidence to pursue my goals and thus achieve my dreams.'



## HONOURING THE SERVICE OF AUSTRALIA'S NAVAL MEN AND WOMEN

Before Federation, colonial naval officers were recognised for steadfastness and courage while serving in South Africa and China. This tradition was enhanced by the Royal Australian Navy (RAN) through its distinguished record during World War I. Navy men won Australia's first awards for gallantry in the face of the enemy in 1914, and they went on to consolidate this reputation for excellence and daring in European, Middle East and Asian theatres of war and throughout the uneasy peace that followed.

In 1939 RAN men - and later women - went to war again, cementing our Navy's reputation as a steadfast ally and determined enemy, and from 1946 the RAN fought in Korea, Malaya, Malaysia and Vietnam while developing its capabilities for sustainment, training and naval diplomacy in a Cold War world. Its Middle East engagement, from the 1991 Gulf War to this day, and in sensitive operations in the South Pacific and Southeast Asia demonstrated our Navy's capabilities and gained it international respect through the service of its men and women.




Now, in *Bravo Zulu* (navalese for 'Well Done'), Australians have a magnificent resume of the trials, tribulations and triumphs of their Navy in 115 years of service, illustrated by individual accounts of its men and women who received Imperial, Australian and foreign honours and awards for their service, gallantry or bravery. *Volume 1* covering the period 1900-74 was released in 2016. Launched by Australia's Chief of Navy in November 2018, *Volume 2*, covering the period 1975-2014, concluded this nine-year research project.

The second book, with 882 pages, describes the development and activities of the RAN from 1975, with separate chapters devoted to the Navy's role in the 1991 Gulf War, in the 1999-2000 UN East Timor peacekeeping operation, enforcement of UN sanctions on Iraq, the 2003 Iraq War the continuing service

of naval people in Iraq and Afghanistan, ashore and afloat and, of course, border security operations in Australia. Above all, *Bravo Zulu Volume 2* is about people labouring mightily to ensure that Australia's Navy is acknowledged internationally for its organisational capability and operational reach.
